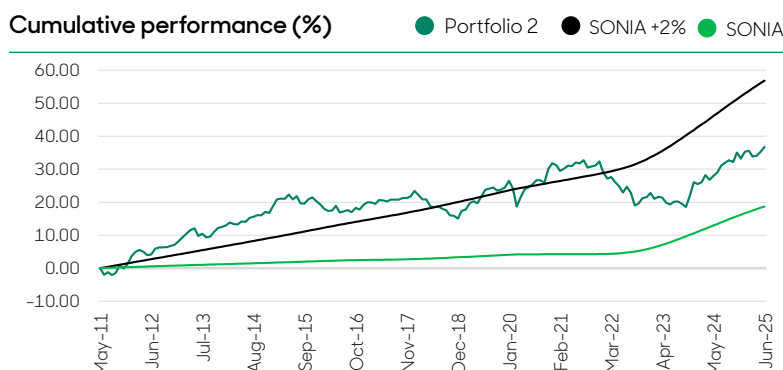
### Investment objectives

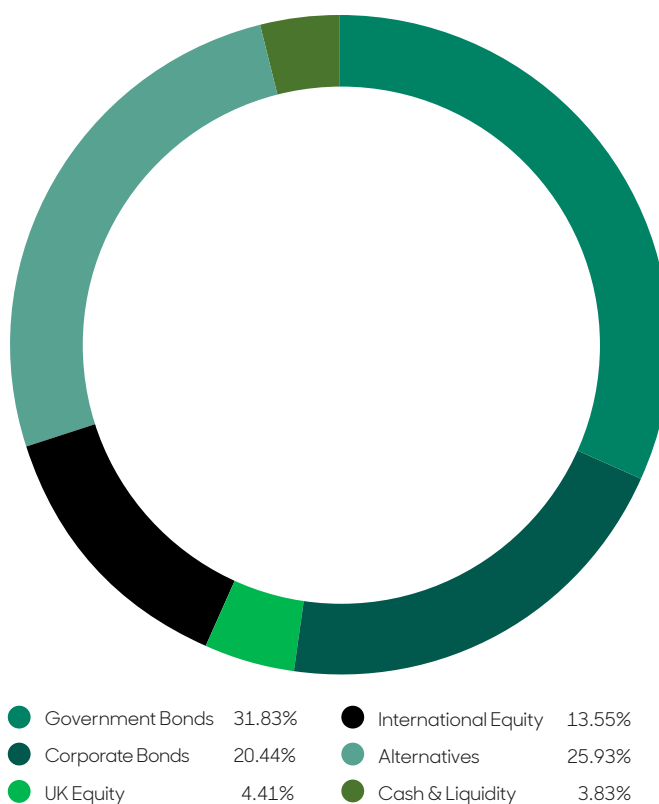

## Risk profile

The investment strategy for Portfolio 2 looks to find the optimum balance between risk and return potential.

It is likely to be suitable for clients who are prepared to accept only a relatively small amount of risk during the time horizon of their investment.

They accept that some risk is required to meet their growth aspiration but want to keep the extent and length to negative growth periods to a minimum. It is designed for customers who, under normal circumstances would not expect their investments to fall and rise sharply in value.

Remember, investors could get back less than they invested.

- Suitable for investors with basic investment knowledge.
- Suitable for investors wanting to preserve capital.
- Suitable for investors wanting a positive absolute return over the medium to longer term (3-5 years) but with easy access to their cash.
- Suitable for investors who are looking to invest in a standalone portfolio.

## Investment strategy

The Target Return investment strategy prioritises the management of market volatility primarily through diversification of portfolio risks. The strategies used are designed to allow customers to benefit from the growth potential offered by market based investments while at the same time managing the risks. This is achieved by avoiding significant holdings in a single market or investment idea and by selecting markets or investment ideas that produce positive returns in differing economic conditions.

## Risks

All investments involve risk. The risks of some of the funds may be comparatively high. **Credit risk:** The fund invests in securities which are subject to the risk that the issuer may default on interest or capital payments.

**Interest rate risk:** The fund price can go up or down daily for a variety of reasons including changes in interest rates, inflation expectations or the perceived credit quality of individual countries or securities.
