How to search for share class funds:

1. Search by fund code – either Citicodes, Sedol or ISIN can be used.
2. Search by fund name, use shorter simpler searches to get greater results.
3. Fund codes can be typed directly into the table or multiple funds codes can be pasted into the table to see the cheapest equivalent of an existing portfolio of funds.

What is shown in the results table?

4. **AMC:** Annual Management Charge. (Includes the fund manager rebate where applicable).
5. **Rebate:** This is the proportion of the AMC which is passed back (rebated) by the Fund Manager.
6. **TER/OCF:** Total fund costs are called Total Expense Ratio (TER) or Ongoing Charges Figure (OCF) which are made up of the AMC and other operating costs.
7. **ISA/PIA net TER/OCF:** This is the TER or OCF less the Fund Manager rebate.
8. **GIA net TER/OCF:** This is the TER or OCF less the Fund Manager rebate. (The value of the rebate includes the deduction of basic rate income tax).

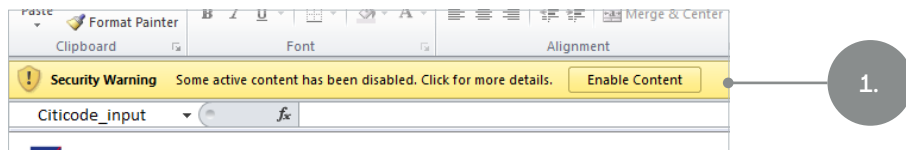
9. Check the boxes in this column and click the 'Remove' button to remove funds from the list.

What you will need to do

1. To search for a fund enter the fund code into the relevant data entry field in the 'search options' section and select the 'Search' button.

2. If the fund code search finds a precise match then the fund details will be displayed in the results table shown.

If you search using a retail, clean or even a super clean, if a match is found you will be presented with the cheapest variant of that fund available on the Elevate platform.

3. Alternatively you can search using a full or partial fund name, enter the details into the 'Fund name' field under 'Search options' and select the 'Search' button.

4. You will then be presented with all the search results which have been found. You can scroll to browse the list and select the fund by clicking it. on screen to highlight it and then the 'Select' button.

Tips

Use shorter, simpler searches to get greater results.

What you will need to do

1. The selected fund will be added to the results table.
2. If you hold a list of fund codes in an existing Excel spreadsheet, you can paste these directly into the results section of the tool, the tool will automatically search for each fund code and pre-populate the remaining columns with the fund information.
This function supports Citicode, Sedol and ISIN fund codes. Your list doesn't have to contain just one type of fund code, the tool will support a mixture of each.
3. If you wish to clear the results table, tick the 'Select all' box and click the 'Remove' button. All fund lines that has been selected will be removed.
4. Alternatively, to remove a fund from the results table, tick the box under the 'Remove from list' and click the 'Remove' button. Each fund line that has been selected will be removed.

Tips

When a fund is removed from your list, the list will re-order the funds.

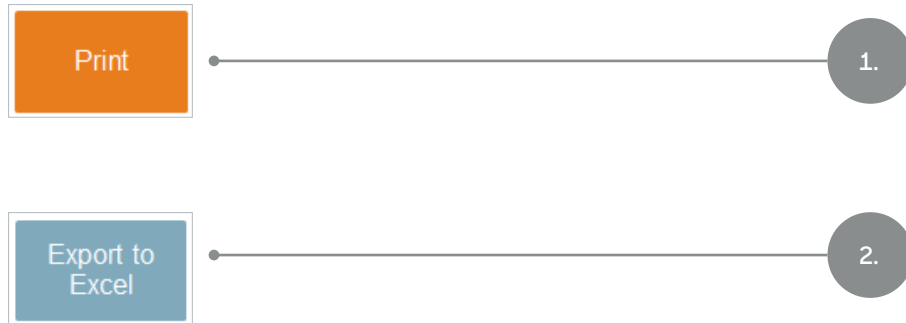
What you will need to do

1. To run a report, select each fund you wish to include by clicking each tick box for the fund under the 'Include in report' column or select the 'Select all' tick box under the 'Run report' button to select all the funds.

Once you have selected the required funds click the 'Run report' button and you will be presented with your report.

Printing and exporting your report

Printing

1. Once the report has been generated (see the 'Run a report' section) you can print the report in the same format with the column heading duplicated on multiple pages by selecting the run report.

Exporting

2. You can also export your report into a separate Excel workbook for further analysis; to do this you can quite simply select the 'Export report' button from the report page once the report has run. A new Excel window will then open with the replicated retail and clean fund data within.

Glossary of terms

This section provides a brief explanation of each of the column headers with in the tool.

Citicode/Sedol/ISIN

When adding a fund to the tool from the 'Search options' section this column the results will be added to the tool.

The details held under this column will default to and present the Citicode, see 'Search for a fund' section on how to do this.

This column can also be used to import a pre-prepared fund list from another spreadsheet, see the 'Import fund lists by fund code' section.

Fund name

This column will show the abbreviated Retail fund name which has been searched for by either using the fund code or partial fund name.

AMC

AMC is the abbreviation used for Annual Management Charge.

Rebate

Will detail the rebate applied to the retail fund in question. This figure is before basic rate income tax which will be deducted from rebates paid in the GIA. (The effect of the tax deduction is shown in the 'GIA Net TER/OCF' column.)

TER/OCF

This column shows the total fund costs based on the Total Expense Ratio (TER) or the Ongoing Charges Figure (OCF) which are made up of the AMC and other operating costs.

ISA/PIA net TER/OCF

This column shows the net TER/OCF applicable to the Elevate Individual Savings Account and Personal Investment Account.

This figure is derived from the 'TER/OCF' minus the 'Rebate'.

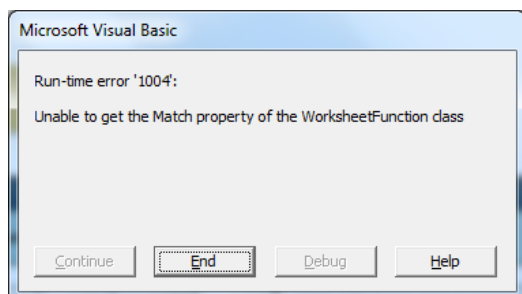
GIA net TER/OCF

This column shows the net TER/OCF applicable to the Elevate General Investment Account and includes the deduction of basic rate income tax from the value of the rebate payable.

Frequently asked questions

1. I get a Run-time error '1004'

This type of error is generated as a result of the spreadsheet trying to process unexpected data from the 'Inputs' page.



One example of how this can occur is if the fund code was deleted by mistake but the 'include in report' tick box remains ticked.

Simply untick the box and select the 'Run report' button.

Another example could be if there is data in the 'Citicode/Sedol/ISIN' column which isn't an actual fund code or isn't held in our source. This should be indicated with the '#VALUE!' in the columns as shown below.

To resolve this issue remove the fund from the list. See the 'Remove funds' section for how to do this.

2. I'm searching for the Fund Manager name with no results?

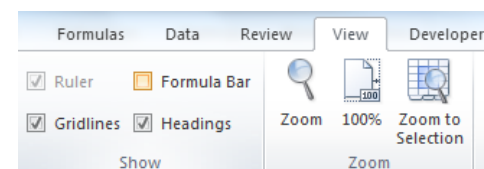
Unfortunately the tool does not currently support a search by Fund Manager name. The tool has been programmed to search for funds by using either fund codes or the Fund name.

3. I'm searching for the Fund name with no results?

The fund names held within the tool are the abbreviated fund name, for example the 'Architas Multi-Asset Passive Progressive Fund Accumulation' would be searchable as 'Architas MA Passive Progressive Fund Acc'. Try abbreviating the name as it is published in industry media.

4. The formula bar has disappeared from Excel?

If this happens select the 'View' tab to show the options available under the 'view' toolbar. Then select the 'Formula Bar' tick box and this will now show on screen.
